Work and Volunteer History:

Carol joined Esso Mathematics and Systems Department of Standard Oil of New Jersey in Florham Park, New Jersey, in 1965. Initial assignments included: computer systems modeling of refinery unit operations; development of software to support cost estimating processes; operating system support and systems programming. Carol subsequently held assignments of increasing responsibility as Section Head of computer applications supporting various Exxon business departments. In 1978 she transferred to the Marine Department of Exxon Company, USA in Houston where she was responsible for business and project analysis of tanker systems. Later assignments included: Controllership functions in budgeting and performance analysis; Marketing Financial Coordinator; Marketing Systems Coordinator with responsibility for oversight of all computer projects for Marketing; member of the ExxonMobil merger transition team; training coordinator for management controls in computer functions.
